STUDENT INFORMATION AND PERSONAL DATA

- Identity document
- Tax code issued by the Revenue Agency
- For disabled and invalid students, latest certification attesting the condition of intermediate disability, severe disability and lack of self-sufficiency
- University or Degree course the student is enrolled in or for which he/she intends to enrol
- University registration number if already enrolled
- Amount covered by scholarship received in the years 2019 and 2020

INCOME AND PATRIMONIAL INFORMATION CONCERNING THE STUDENT AND HIS/HER FAMILY UNIT

For autonomous or non-autonomous students who are resident in Italy and whose family unit also resides in Italy:

- Copy of the University ISEE declaration and ISEE certification concerning the student and his/her family unit residing in Italy (if applicable)

For students not residing in Italy or who, despite being resident in Italy, are not autonomous and whose family unit is resident abroad:

- Copy of the University ISEE declaration and ISEE certification concerning the student and his/her family unit residing in Italy (if applicable)
- Composition of the family unit residing abroad: surname, name, date of birth, tax code (if applicable), family relation to the student
- Certification concerning the income of each member of the family unit residing abroad
- Certification concerning the real estate assets owned in foreign countries by each member of the family unit residing abroad
- Certification concerning the foreign financial assets (e.g. current accounts) in the name of each member of the family unit residing abroad
- In the event of rental, documentation concerning the value of the yearly fee indicated in the rental contract
- Students from particularly poor countries represent an exception to the cases indicated above. The assessment of their income requirements will be performed on the basis of documentation issued by the Italian Diplomatic Authorities in their country of origin, certifying that the student is not part of a family known for its high income and elevated social status

NOTE

The documentation the student provides to the CAF to obtain the issuing of the university equivalent indicator must be issued by the competent authorities in his/her country of origin and translated into Italian by the competent Italian diplomatic authorities in his/her country. The documents must be legalised by Italian diplomatic authorities or embassies in his/her country of origin or annotated by the competent internal authority if the student's country of origin has joined and ratified the October 5th 1961 Hague Convention.

We furthermore wish to underline that, in order to request and receive university benefits, the student must check the requirements set forth in the notice published by the University or Institution concerning the right to university education, so that he/she may be aware of deadlines, modalities for transmitting documentation and the correct nature of documents to be provided to the Institution offering the benefit in question.
